Our services are crucial because research has shown effective cancer care requires the integration of psychological and social services, like what CSCAZ provides, with medical treatment to address issues associated with a cancer diagnosis and prognosis. A failure to provide supportive care to cancer patients and their loved ones can result in additional suffering, reduced adherence to physician prescribed care, and a delayed return to best health status. Through our Resource Navigation program, we help patients and families access resources such as financial, transportation, food, and lodging assistance, and offer free wigs to individuals who are losing their hair due to treatment. It can be overwhelming for Arizonans to navigate the cancer landscape, so CSCAZ helps ease the worry and burden of the cancer experience. In 2023, we served 1,865 individuals directly through our programs, and helped over 3,861 families access resources to overcome barriers to care.
